"Incredible. We got great shots of places where Darwin took long treks away from the ship in 1835. He was only 26."

"How is the video quality?"

"Excellent."

"Then you should be close to final editing." He smiled. "This may be another award winner."

Pamela knew Sam's compliment was genuine and intended for the whole team.

"Yes." She paused. "Actually, that's why I wanted to talk with you."

"What's up?"

"Well." Pamela took a deep breath. "We've produced a great documentary on Darwin, edifying his theories of Evolution and Natural Selection." She gently twirled the pendant with her right hand. "The problem is that I'm not sure his theories make any sense."

Sam's eyes widened. "What do you mean?"

Pamela slowly opened her file. "As I've gone through this process and traveled to all these places and interviewed all these people, the same thing keeps happening. Each of these brilliant people repeats some version of the 'fact' that Darwin's theories are well proven and beyond doubt. But when I ask them even the simplest question, there always seems to be a problem."

Sam scratched his head. "Problems with evolution? Like what?"

"Well, I'm talking about macro-evolution-they call it speciation. Not just that later generations of the same species are larger or slightly different. But the idea that one species actually changes into another. Take as an example the fossil record.

"Wouldn't it make sense that if all of the species we see on earth today evolved from earlier species, we would find the fossil remains of those in-between creatures? Like the ones that would be half way between a dinosaur and a bird, or between almost anything and something else?"

"Yes, of course."

"Well, there aren't any."

"Impossible," Sam said. He knitted his brows and swiveled in his chair.

"That's what I thought, too. But there really aren't. Well, there are a couple that Darwinists hold up as possibles. But compared to the tens of *millions* of fossils of species that existed earlier"-she raised the pendant slightly-"and either still exist today or are extinct, there really are none of the 'tweeners.""

"How can that be?"

"I don't know. It even worried Darwin. He had to devote a whole chapter in *Origin of Species* to try to explain the problem away. I'm sure he thought that by 150 years later, we'd have found many of these fossils. But we haven't. Evolutionists today still call it a 'mystery."

The older man leaned back, accompanied by a creak from his chair. "I've never heard that. I find it hard to believe."

Pamela nodded and turned a page. "And here's a related one. There may have been life on earth for four or five billion years, but mostly it was bacteria. "What do the scientists say about this?"

"They just repeat that the missing fossils will surely be found, as Darwin predicted."

"But I'm sure I've seen textbooks-when I was a kid, even-with those intermediate forms clearly displayed." Sam made an upward motion with his hands.

She nodded. "That's what I'm talking about. Everyone says that they 'must' exist. So far there are tens of millions of scientifically catalogued fossils, but few if any of the in between ones."

He sat in silence as Pamela continued. "And that's not all. In fact, there's lots more. Do you want to hear them?"

Sam nodded. He leaned forward and offered her a chocolate candy from a glass jar on his desk.

She smiled. "Thanks." Each unwrapped a candy and let it dissolve in a few moments of silence.

Pamela continued. "Okay. Here's one of my personal questions. It's the eye thing. How does vision *evolve?* I mean, how and why do all of the incredibly complex pieces-nerves, receptors, lenses, the optical part of the brain-all of that-

start to fit together, long before there is any vision, to create what you eventually need for an eye to function? What's the 'natural selection' going on, if there's no payoff of actual vision for a zillion years, to keep the process going? How does a lens 'learn' to focus, if there's nothing yet connected to it? And then how could this near miracle happen over and over again in so many different species and so many different places?"

Sam shook his head. "I don't know. I never thought about it. What do the scientists say?" He reached for another chocolate, unwrapped it and popped it into his mouth.

"They're not sure. They just say that it must have occurred over a long time. I mean, how would some blind thing just happen to develop all of the myriad parts necessary for vision while still blind? What trait would it have that would make it better, and therefore dominant, when it was still as blind as everything else?

I don't get it."

Sam sat in silence, pondering her words. "Anything else?" He seemed to have lost the chipper spirit with which he'd greeted his friend.

Pamela turned a few pages. "As a sort of an aside, Darwin assumed that small building blocks, like bacteria, would be simple organisms from which more complex life forms evolved. But with modem microscopes, we now know that bacteria and other tiny creatures are actually incredibly complex, fine tuned, well-oiled machines. In fact, it's difficult to find any form of life on earth that isn't very, very complex. That suggests to me that everything started out complex, rather than evolving from something simpler. There just aren't any simple life forms anywhere."

Sam frowned and leaned forward again, his hands on the desk. "So what are you saying?"

Pamela's eye fell on a page in her folder. "Oh, here's one you should particularly like. Did you know that Darwin thought Negroes were 'tweeners,' a link between apes and humans? By higher humans he and his followers always meant Caucasians."

"What?" Sam took the page copied from Chapter 6 of *The Descent of Man* and read aloud.

At some future period, not very distant as measured by centuries, the civilized races of man will almost certainly exterminate, and replace, the savage races throughout the world. At the same time the anthropomorphous apes, as Professor Schaaffhausen has remarked, will no doubt be exterminated. The break between man and his nearest allies will then be wider, for it will intervene between man in a more civilized state, as we may hope, even than the Caucasian, and some ape as low as a baboon, instead of as now between the Negro or Australian and the gorilla.

He looked up at her, perplexed. "So Darwin was a racist?"

"Sort of, but not out of hate. Just 'science.' He predicted that whites would annihilate the 'savage races' in a few generations. Not because he wanted it-he was opposed to slavery-but because that would be the result of natural selection. How do you like being a link in the chain to better white people?"

Sam slammed the paper down. "That's absurd!"

Nodding and holding up her hands, Pamela said, "But that's the theory that we're about to celebrate in our documentary as being a proven fact."

"It's not true." Sam's anger had risen, along with his voice.

"And he said the same thing about women. Let me read from chapter 19 of the same book."

The chief distinction in the intellectual powers of the two sexes is shewn by man's attaining to a higher eminence, in whatever he takes up, than can woman- whether requiring deep thought, reason, or imagination, or merely the use of the senses and hands. If two lists were made of the most eminent men and women in poetry, painting, sculpture, music (inclusive both of composition and performance), history, science, and philosophy, with half-a-dozen names under each subject, the two lists would not bear comparison. We may also infer, from the law of the deviation from averages, so well illustrated by Mr. Galton, in his work on Hereditary Genius, that if men are capable of a decided pre-eminence over women in many subjects, the average of mental power in man must be above that of woman.

"Ridiculous!"

"Can you think of any other white male we would honor who 'proved' that blacks and women are inferior to white males?"

Sam scowled his answer.

Pamela continued. "It's all part of evolutionary 'fact.' And everyone thinks evolution's true. So is it, or isn't it?"

"That part isn't."

"Are you a scientist?"

"No, but I know I'm not some link between apes and white people!"

"So with Darwin saying Negroes and women are less than human, and we can find no fossils of any in-between animals, and complex creatures appear almost at once, and no logic fits the evolution of something complex like vision, or flight, then which part of Darwin's theory of evolution *do* you agree with?"

Sam stood up and paced toward the window. His hands cut the air as he answered. "I don't know. I never thought about it. I just always thought that evolution was obvious."

"Right. Me, too. And if it's not? If it's wrong?"

Sam stopped and looked out the window. "Then...I don't know. Maybe we just 'happened.' Or something or someone created all of it." He turned back to Pamela. "I can't think of a good answer right now."

"But if someone or something created us, isn't that kind of defining?"

"What do you mean?"

"I mean," Pamela stood up and moved behind her chair, "that if all of this very complex world *were* created by someone, then wouldn't he, she or it have some ideas on how it ought to work? And what we ought to do and not do?"

"That may not matter. And how do we know, anyway? Maybe it is true."

"Well, maybe it is. But in ten minutes we shot it full of major holes, and no one out there seems to have answers that will plug them. Surely we ought to at least give equal time to other theories, when this one is so lame."

She could see the fury in her boss. He pointed his index finger as he spoke, "Listen, Pamela. You and I are not going to produce our own little show to question two hundred years of proven facts about evolution. Who are we to do that?"

"But they're *not* proven facts. That's what everyone thinks, because they don't ask the simplest questions. There are no evolutionary fossils, Sam!"

"Maybe there are, and we just haven't found them yet."

"Come on. You're starting to sound like a preacher, not a reporter, urging me to 'believe' in non-existent fossils. Maybe Darwinism is more of a religion than most religions. Just *believe*, and it's true."

We can't just show up two hundred years later and doubt evolution. Can you imagine what that would mean? # 2----History

The latch clicked and his younger colleague, Sandra Murphy, walked in carrying file folders and papers. She smiled and went to the counter by the sink to pour hot water. They enjoyed having tea together during their mutual free period.

"Looks like we finally got them," she said, holding up the papers. "This ought to silence them once and for all."

"Nice to see you, too." Gillies smiled. "When are you going to learn that in the South we say 'Hello' or 'How are you?' before launching into a declarative sentence?"

She smiled, put the papers under her arm, and picked up the oversize mugs. He put the essays on a table next to his chair and took the warm mug she offered.

She stood in front of his chair. "All right. Harrison, how are y'all?"

"Fine, thank you. But just because I'm heavy doesn't mean I'm plural."

"Sorry. I thought the term applied universally."

"No, it's much more complex than the simple 'you'. You'll get the hang of it one day."

She laughed. "Actually, when I call home it slips out sometimes. They're always aghast. And I like grits, too."

"There's hope. But now that we've reminded you to 'whittle and spit' a little, what were you talking about when you came in?" He sipped his tea and motioned her to the sofa on the other side of the table.

"Here, I brought you a copy." Murphy handed him three pages and sat on the sofa. Moving the pencil she was carrying to the table, she used both hands to pull back her light blond hair. "The Supreme Court just issued a ruling that should finally make things clear."

Gillies adjusted his glasses. "Let me see." He read aloud.

Washington, DC (AP). June 17, 2011. In a 5 to 4 decision, the U.S. Supreme Court ruled today that the Declaration of Independence, along with President Washington 's Inauguration and Farewell Addresses, may no longer be displayed or read in public schools.

Citing the First Amendment, the court ruled that because there is a reference to God in each document, it is a violation of the Constitution's prescribed separation of church and state to include the Declaration of Independence or Washington's speeches in public education.

In addition, the display of the documents in government buildings and in other facilities supported with federal funds is also banned.

Gillies lowered the press release into his lap and looked over at his colleague. "This is pretty strong." She eased back into the cushions on the sofa. "Yes, thank goodness." Each of them took a sip, and Gillies picked up the press release.

Writing for the majority, Chief Justice Diane Timmons-Fulton ruled that "American school—children will no longer be subjected to the narrow and bigoted view that the male imaged Judeo-Christian God, some other god, or any other religious construction was involved in the creation of our country."

Speaking of George Washington and the other Founding Fathers, the Chief Justice wrote, "Either they were misguided at the time, or they did not foresee the implications of their personal beliefs on future generations. In either case, the court cannot allow words written over 200 years ago to improperly influence the citizens of our nation to believe in God, or in any other specific divine being."

Federal, state and local governments will have one month to remove all copies of the documents from public buildings, and local school boards will have a year to acquire new history books that do not explicitly quote the texts.

"I suppose your History Department will be investing in new textbooks."

"Yes, though the ones we've been using for years don't mention those speeches by Washington."

He smiled and turned slightly in his chair. "Why are you so strident about this ruling?"

"Harrison, come on! We've both been on the receiving end of those parents' e-mails and conferences where they want us to allow students to say anything about their faith here at school. If we did that, we'd have Christians berating Jews, Jews hating Muslims, and all of them ganging up on the atheists. The only safe way is to allow none of it. Keep all religions out of school. And clearly the Constitution requires it."

Gillies frowned and took another sip of tea before reading the second page.

In writing the minority dissent, Justice Wilton Thrower argued that "it would take many pages of single spaced entries just to list all of the public documents in which the Founding Fathers explicitly mentioned the Judeo-Christian God, His Son Jesus Christ, and their dependence on Him for guiding them through the ordeal of birthing this unique nation. Not only is this ban historically inaccurate, but it also strikes a blow to the one true Foundation of our country."

Justice Thrower pointed out that the First Amendment was specifically written to prevent Congress from "establishing" a central religion for the nation, that it guarantees free expression on all religious issues, and that the term "Separation of Church and State" never appears in the Constitution or the Bill of Rights.

"Denying our nation's dependence on God has become a gross distortion of the intent of the Founders. They always *encouraged* the influence of religious thought in public policy.

"In addition, until the 1970s, generations of public school children grew up reading these two important speeches by our first and greatest President. In them Washington gives the formula for the continuing success, safety, and prosperity of our nation, the key element of which is an abiding belief in God and adherence to His commandments."

He looked up. "What do you think of that?"

She shrugged. "It doesn't matter what I think. The Constitution creates a wall between church and state. Period." Her older mentor nodded. "Justice Thrower says it doesn't, and that the First Amendment is only talking about Congress establishing a state religion."

"Well, if anyone talks about God in a public school, that's exactly what they're doing." "Is it? Are we Congress? We're a school."

The management team pushed back from their tables, talking, sharing notes, and beginning to shift gears from training to the tasks of the day. The CEO, Ray Walters, ten years younger than Brian, came to the table and extended his hand, beaming. "This is just what we've needed. We have a great team, but we haven't always been pulling in the same direction. Your course is already having an impact on how we approach problems and challenges. Thank you so much."

He had helped thousands of people in hundreds of companies attain their goals-or certainly at least get closer to them. It was very satisfying work. He, Marilyn, and their three children planned each month as part of their family's annual plan, and it would soon be time to finalize the year's vacation activities. He couldn't imagine why everyone wouldn't embrace the techniques he taught once they heard them, and it was with that fervor that he always approached his prospecting calls.

Anyway, I started that with my first tenth grade class...Let's see, it's been almost fifty years ago. Do you believe that, Bill? And I've kept it up ever since."

Her husband nodded at his wife but spoke to Brian. "She's got two big journals. You wouldn't believe'em. She has *eveiy* student from every year she taught. What she's been praying, how the prayers were answered, new requests, addresses, phone numbers, children. She knows about almost every one of them, and they talk all the time with 'Mrs. Demere.'

"Then when Marilyn and our other kids came, she would always stop whatever she was doing and listen to them. It didn't matter whether the house got cleaned or the laundry done. And listening to them is something Joyce still does pretty regularly." Marilyn patted her mother's hand. "She always has."

"I think it's sort of like electricity," Joyce smiled. "If I take the time to really connect with someone, then God lets the power flow to change lives, including mine."

"What about you, Bill?" Brian asked. "You seem to know everyone whom you grew up with."

Bill laughed. "And a few more, I guess. I don't have a journal like Joyce does. But I have always tried to be on the lookout for people who need some help-maybe a little money, a nudge finding a job, a little counseling when a marriage hit a rough spot.

"It's been sort of a habit of mine for a long time. It seems like when you do that, people come back to you. So I've connected and reconnected with people. If you keep your ears open, you learn a lot about people. That usually leads to more ways to help them. Or to suggest how they might help others. Then it just repeats. You know, it's really kind of fun."

Brian considered his father-in-law's words before he spoke. "It's actually been a lot of work, hasn't it?"

The older couple looked at each other. "Work? No, I wouldn't say that," Joyce answered. "Like Bill said, it's really kind of fun. What life is all about."

"But I mean you've thought about it. You've kept some notes. Been intentional."

"Well, I guess if that's work, then Okay, we've worked at it. But the notes have been to jog my memory. The 'work' is just talking to people. Listening, mainly."

The next morning Brian, Marilyn and their children attended Sunday school and church. Their pastor, Ron Taylor, chose to speak on relationships. He cited numerous Bible verses, from Genesis 1-3, Romans 1, 4, 14-16 and 21, and Luke 15, all showing that God had created people in order to have the joy of fellowship with them, not to use them as servants or slaves.

Taylor recounted all the times that God *spoke*, indicating His desire for communication, from the creation of the universe to the teachings of Jesus. In fact, the Apostle John referred to Jesus as "the Word."

If we think about the people who have influenced us the most, I believe that we are as much influenced by who they *are*, and the genuine concern they have for us, as we are by what they have done. And the only way to express that concern is through a relationship that builds deep and lasting two-way conversation."

When Taylor concluded, Brian knew that this was one of those times when the message seemed to have been written personally for him.

That evening Brian went into his study and spent an hour reading the texts that Ron Taylor had cited, plus some others. And he prayed.

On Monday morning he asked his assistant to reschedule as many of his commitments as possible for the following week. He spent the day reading the Bible, praying, and fasting. That afternoon he made a short list of people with whom he wanted to talk, starting with Ron Taylor, plus others who had been mentors or who had served on his Board of Advisors over the years.

On Tuesday and Wednesday he had six of those meetings and spent more time in prayer. On Wednesday afternoon, he started writing.

Friday morning as Ray Walters and the management team at Core Systems gathered in their training room, Brian was in the parking lot praying. Dressed in his usual blue blazer, gray slacks and an open collar shirt, he joined the class just before 8:30.

Who might give you a different perspective on what's important to do, and wouldn't it be good to have that input *before* you make your *To Do* List?"

There were a couple of nods and some fidgeting. And a few arms folded tightly across chests.

"As a final introduction to this subject, I want to add a personal note. I think this is so important because I believe it is divine." Brian stepped out closer to the class and raised his hands slightly. "I know that we all come from different faith backgrounds, and this is not a course on religion. But I want you to understand me, as the teacher. I don't believe that you can read the basis of my faith-the Bible-without being convinced that relationship and fellowship are at the very core of God's intent for us, first with Him and then with each other. I'll be glad to share references with anyone who is interested after class, but I just want everyone to understand that I feel these next two lessons are actually the reason for the whole course."

The class was silent. Brian smiled. "All right, let's get started."

I want you to stretch muscles that you probably haven't used in a while, especially those two sticking out on either side of your head."

He noticed people looking around the room at each other, some smiling.

"Now divide this list into three groups: Family, Friends, and Business. Add at least five people to each group. You should be able to complete this part of the assignment by tomorrow, which will then give you two weeks to do the main part: Go and *Be* with them.

"Is there someone with whom you should be close but with whom, for some reason, there is an impasse? Start with your spouse and your children, if you feel that *To Do* has gotten in the way of those relationships-and I can tell you in my case it definitely has.

"Ask questions. Find out about *them*, rather than rattling on about yourself. For your Business list, choose a few within Core Systems, but the majority should be outside the firm: customers, suppliers, even competitors. Here you may have to bend the *No Do* Rule and invite them to a ball game, golf outing, or something else, but keep it one-on-one if

you possibly can. The idea is to create an environment in which a relationship can blossom through conversation, not an event that can be checked off.

"For a few of you this may all seem crazy-that I'm asking you to do what you've always just done. I salute you, just like I salute those who are already organized when we're focused on the *To Do* List. But I suspect that in this group of managers, the *To Be* List may be the greater challenge.

"All right. Is everyone clear?" No one spoke. "You have my phone number if you need any clarifications or have any questions. Our goal is to return in two weeks with as much Being time as possible, so make your list by tomorrow, and I look forward to hearing your reports. By the way, I'll be doing the same."

Three members of the class called over the next two weeks, asking for advice on specific situations. Ray Walters, who had seemed a little nervous, if not unhappy, never called. As the class day drew closer, Brian prayed daily and, as he had promised, worked on his own *To Be* List.

When the two weeks were up, Brian walked into the training room just before 8:30. A quick glance showed him that almost everyone was there, though the room was not as noisy as it had been two weeks before.

As the Core Systems executives took their seats behind their tables, Brian went to the front, took out his notes, and spoke.

"Good morning. I hope you had an eventful two weeks. I'd like to get some feedback."

And there are two or three things where each of us is going to give the other a hand. Thank you so much for the *To Be* List."

Ray Walters raised his hand from the middle of the room, and Brian nodded. "Well, I frankly thought that this was sort of a crazy idea when you told us about it two weeks ago. You know, too touchy-feely. A waste of valuable time. But then I figured how much we're paying you for this course, and you added two extra weeks, so I decided I'd try it. I made the list and then I had lunch with two customers and two suppliers. I told them that I didn't want to talk about business, which they couldn't believe, and tried to do anyway, but I wouldn't let'em!" Everyone laughed.

"Once we got past that, we had a great time. We talked about our families, the kids' schools, trips-and, interestingly, after we'd run out of all the standard chitchat, since I wouldn't let them talk about business, we actually got onto some pretty interesting stuff. A previous addiction. Some very talented kids. A marriage in trouble-and I think I know someone who can help. A new home search. A very sick parent. Why haven't we been doing this before?"

"Indeed," Brian agreed, touched by Walters' candor.

Almost everyone in the room shared an experience or two from their *To Be* List that had impacted them in a powerful or unexpected way. Most stories were happy. A few were poignant. Everyone listened.

"I guess I should share as well," Brian said, when the others had all spoken. "I...several years ago a guy I had known and worked with for a couple of years, Don- we-well, we had a falling out. The reason doesn't even matter now. But we had sharp words on two occasions, once in front of others. The last words Don heard from me were in anger. It had sort of bugged me on and off, but never enough to do anything about it.






